Venue. The parties to this Agreement agree that venue for all diputes concerning this Agreement, or concerning the parties' performance under this Agreement, shall be Jefferson County District Court, Jefferson County, Alabama, when the amount in controversy is less than Four Thousand Dollars (\$4,000.00), and shall be Jefferson County Circuit Court, Jefferson County Alabama, when the amount in controversy is Four Thousand Dollars (\$4000.00) or more.

Jurisdiction. The parties to this Agreement agree and consent to jurisdiction over them by the Jefferson County District Court and the Jefferson County Circuit Court, and agree to have either court exercise jurisdiction over them for any and all disputes concerning this Agreement, or concerning the parties' performance under this Agreement.

Choice of Law. The parties to the Agreement agree that law governing any and all disputes concerning this Agreement, or concerning the parties' performance under this Agreement, shall be the laws of the State of Alabama.

Attorney's Fees. Should an action be brought in Jefferson County District Court or Jefferson County Circuit Court for purported violations of the terms of this Agreement, the prevailing party shall be entitled to an additional award of reasonable attorney's fees and costs. The prevailing party shall be determined by the judge, magistrate, commissioner, or other judicial figure who presides over any such proceeding.
