## FIRST ANNUAL FALL JURIED EXHIBITION – SEPTEMBER 1 - SEPTEMBER 30, 2016

1045 Elmwood Gallery for the Arts is holding its first annual (open) Fall Juried Exhibition...with a Spring Juried Exhibition scheduled for March 2017. We look forward to meeting with new and our existing core of artist friends to showcase many fine regional works of art.

**ARTWORK SUBMISSION/DROP OFF:** August 18 - August 20, (Thurs - Sat) 11:00 AM to 3:00 PM. Shipped artwork must arrive by August 18. All shipped entries MUST include return postage. Labels must be completed and attached to the back of each work.

**ARTWORK PICK UP & NOTIFICATION:** August 25 - August 27, (Thurs - Sat) 11:00 AM to 3:00 PM. Notification of works accepted or declined will be available at this time.

**PICK UP EXHIBITED ART:** Works may be picked up at the end of the exhibition - Friday, September 30, 11:00 AM to 4:00 PM. or Saturday, October 1, 11:00 AM to 3:00 PM.

**OPENING RECEPTION & AWARDS:** Saturday, September 10, 2016, 2:00 PM to 5:00 PM. Prizes will be awarded as follows: First - \$300 plus two week solo show to be scheduled in 2017, Second \$200, Third - \$100, plus two Honorable Mentions ribbons will be awarded at the opening reception...approximately 3 PM.

### ENTRY REQUIREMENTS

**SUBMISSIONS:** Artists may submit up to three works for jurying fee of \$30.00.

**YEAR OF PRODUCTION:** Created within the last three years.

**SIZE:** 2D work - no more that 36 inches in any direction including frame, 3D work 9x12x12 inches in any direction. 2D works MUST be wired and ready to hang!

**MEDIA:** No restrictions. Submissions must be original works of the artist.

**PUBLICITY:** 1045 Elmwood Gallery will coordinate press releases to local news media, Facebook, invitational postcards, etc. (Early and agreed upon submissions could be used in post card and press releases)

**SALES & COMMISSION:** Gallery will take a 40% commission on works sold.

**RISK AND LIABILITY:** By submitting artwork for jurying and for allowing artwork to be installed and on view for the duration of the exhibition, the artist releases and discharges the 1045 Elmwood Gallery from any and all claims occasioned by damage/loss of said images, paintings, and/or sculptures while in the possession of the 1045 Elmwood Gallery.

JUROR: Ginny O'Brien

Ginny O'Brien exhibits her art locally and nationally. She conducts workshops and seminars for teachers, artists, and healthcare professionals that include content and methods for using visual art and the creative process for the promotion of good health and wellness. O'Brien is Curator of Education for the University at Buffalo Art Galleries where she develops and leads various programs for diverse audiences with content highlighting the Galleries' permanent collections and temporary exhibitions. She presents her arts, education, and health programming at conferences nationwide, most recently at the 2016 American Public Health Association conference. O'Brien served as a panelist for the program "Building Healthy Relationships: Integrating Academic Museum Programming and Parent Organizations" held at the Yale University Art Gallery, and lectured about her programs at the University of Coimbra, Coimbra, Portugal. The juror received a Master of Fine Arts degree in Studio Art, Fibers, from Syracuse University, and from Buffalo State College she received a Bachelor of Fine Arts degree in Textile Design as well as a Master of Arts degree in Multidisciplinary Studies with an emphasis in Textile Design and Art Therapy. She holds a Bachelor of Science in Nursing degree from Wichita State University, Wichita, Kansas, and attended the Kansas City Art Institute studying fine art, illustration and design. O'Brien was an instructor at Buffalo State College and Daemen College where she taught courses in Fiber Arts and Design, and recently she developed and taught the course "Clinical Humanities: The Intersection of Healthcare and the Visual Arts," offered at the University at Buffalo for undergraduate students studying across disciplines. Her authored publications and creative works are found in art, education, and health-related journals, including Surface Design Journal, Western Humanities Review Literary Magazine, and Family Medicine: Journal for the Society of Teachers in Family Medicine. O'Brien has served as juror and judge for arts associations and galleries featuring group exhibitions, and for arts festivals and centers including "100 American Craftsmen" held annually at the Kenan Center Arena in Lockport, NY, and "Allentown Arts Festival" held each summer in Buffalo, NY.
